**SUPPLEMENTAL DECLARATION OF RESTRICTIVE COVENANTS
FOR CRYSTAL CREEK
PHASE 2B**

THIS SUPPLEMENTAL DECLARATION is made this 25th day of February, 2013, by Four Star Development Group, Inc., a North Carolina corporation, hereinafter referred to as Declarant.

WITNESSETH:

WHEREAS, Declarant is the owner of certain real property located in Smithfield Township, Johnston County, North Carolina, which is more particularly described as all of the Lots in Crystal Creek Subdivision, Phase 2B, recorded in Plat Book 78, Page 180, Johnston County Registry, reference to which is hereby made; and,

WHEREAS, Declarant will convey said real property subject to the covenants, conditions, restrictions, reservations and charges as set forth in those certain Restrictive Covenants recorded in Deed Book 4077, Page 34, Johnston County Registry, amended in Deed Book 4221, Page 2378, Johnston County Registry, and which shall run with the lots and be binding on all parties having any right, title or interest therein and their heirs, successors and assigns, and which shall inure to the benefit of each owner thereof; and,

WHEREAS, Declarant desires to insure the most appropriate development and improvement of each lot, to protect the lot owners against such improper use as would depreciate the value of the property to each, to preserve insofar as practicable the natural beauty of each lot, to guard against the erection thereon of poorly designed or proportioned structures and structures built of substandard or unsuitable materials, to secure and maintain proper setbacks with adequate free space between structures, and in general to provide for a high quality of improvements.

NOW, THEREFORE, Declarant hereby declares that all of the real property as described

hereinabove shall be held, sold and conveyed subject to those certain Restrictive Covenants that are recorded in Deed Book 4077, Page 34, Johnston County Registry and amended in Deed Book 4221, Page 378, Johnston County Registry..
